Choosing an SCC Membership Name

The membership name you choose will be shown as your company name in the Provider Directory. You will be able to update all of the location and contact information in the directory except for the membership name. The SCC membership chairperson can change that for you, but only under certain circumstances.

We wish to insure that the owner of a membership maintains control of that membership, so we don't allow an individual to take a membership to a new company unless they are the only owner of that membership. So, please select a membership name that indicates ownership when it might not be clear. For example, a realtor with the membership name, "Mega Homes Realty – Betty Smith," could later have the membership name changed to "Homes R Us – Betty Smith." But if the membership had been named "Mega Homes," Betty would need to buy a new membership to represent "Homes R Us." Companies with a sole owner do not need to indicate the owner's name as part of the SCC membership name.

Franchises: Please indicate the company name followed by a geographical designation. For example: Excellent Home Care, Inc. of West Seattle.

Choosing a Category

On the SCC website there is a feature called *Find a Provider* that is accessible to the public. People can ask to see all SCC members that belong to a particular category. Please select one category from the list on the left to be your primary category.
